

Daylight Singers

We're delighted you have decided to join a Daylight Singers group. We hope you'll really enjoy singing with us!

There are a number of different ways you can choose to pay for your membership of Daylight Singers, from Pay As You Sing, through to becoming a Subscriber. However you decide to pay, we only charge for rehearsal sessions, and you don't need to pay for Tea, Coffee, Biscuits, or to perform in our concerts.

Subscribers

Our subscribers **save 20%** compared to those who pay weekly. That's the equivalent of almost **8 free sessions** a year. For each Calendar year we work out the number of sessions for the year, and spread the cost with 12 equal monthly payments, made via Direct Debit. In addition to your Daylight Singers sessions, Subscribers also receive discounts on other Laar Music courses.

Join on 10th January 2017, and that works out at £13 a month, for 39 sessions.

Direct Debit's are set-up online, and are processed by GoCardless. We will send you a link to the DD mandate, or you can find a link on our website www.laarmusic.co.uk/daylightsingers

Half Termly

You may decide that you'd prefer to pay for each half term, and if you do you will **save 10%** compared to those who pay weekly. You can pay by cash, cheque (made payable to 'Laar Music'), or by Credit / Debit Card. Each Half Term fee may fluctuate depending on the number of sessions in that half term, but as a guide, a 6 week half term in 2017 would be £27.

Pay As You Sing

This offers the most flexibility to you. Simply come along when you can, and pay weekly for the sessions you can make. £5 a session.

Terms and Conditions

- 1) Laar Music Daylight Singers Subscription is a 12 month subscription.
 - a. You have the right to cancel your subscription at any time, with the following terms:
 - i. Should you cancel before the end of the 12 month contract, you agree to pay Laar Music pro rata for all available sessions between the start and cancellation date of your subscription.
 - ii. In the event of a cancellation before the end of the 12 month subscription, all available sessions shall be charged at the Half Termly Session Fee rate as advertised.
 - iii. If you owe Laar Music any monies owing will be taken in the final Direct Debit payment.
 - iv. If you have over paid and Laar Music owes you, a transfer will be made directly into your account within 30 days.
 - v. Should Laar Music cancel the service, you will only be charged for the available sessions. A pro rata fee will be calculated based upon the available sessions for the start date to the cancellation date. Should you owe Laar Music funds, this will be taken in your final Direct Debit payment. Laar Music will reimburse you for any sessions you have paid for which do not take place.
- 2) Laar Music Daylight Singers Half Termly membership is a flexible block of sessions, within the academic half term dates, as set out by the Local Education Authority.
 - a. By purchasing Half termly membership, you are agreeing to pay for all available sessions within the half term, with the following exclusion:
 - i. Should you begin a Half Termly membership after one or more sessions of the Half Term block, you will be charged a pro rata rate. This rate will cover all available sessions from the start date, until the final available session of that half term.
 - ii. Should Laar Music cancel the service, you will only be charged for the available sessions, and will be reimbursed for any sessions you have paid for which do not take place.
- 3) Laar Music Daylight Singers Pay As You Sing, enables you to access individual sessions for a one off set fee, payable for each session attended. This is not a membership or subscription.
- 4) The Subscription, Half Termly Membership, and Pay As You Sing fee may increase or decrease. Should the fee change, you will be given 30 days' notice, during which time you may accept the charge and continue to use the service, or you have the right to cancel without surcharge. If we are unsuccessful in our attempts to contact you, or do not receive reply, we will presume you accept the amended fee.
- 5) The day, time, and venue of sessions, whilst unlikely, may change. Should the day, time or venue change, you will be given not less than 14 days' notice, during which time you may accept the change and continue to use the service, or you have the right to cancel without surcharge. If we are unsuccessful in our attempts to contact you, or do not receive reply, we will presume you accept the amendment.
- 6) We can make reasonable changes to this agreement at any time. All changes will be posted on our website. Please check regularly for updates.
- 7) If we change the terms and conditions of this Agreement to your significant disadvantage (in our reasonable opinion) we will give you 30 days' Notice in advance.
